

RESOLUTION NO. 2024-R-124

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN OWNERSHIP, STORAGE, AND MAINTENANCE OF MATERIALS AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND GREATER NORTH MIAMI HISTORICAL SOCIETY, INC., TO PROVIDE FOR THE STORAGE OF HISTORICAL MATERIALS AND ARTIFACTS IN CITY FACILITIES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Greater North Miami Historical Society, Inc. ("Historical Society") is a non-profit organization created to engage and encourage historical inquiry, to collect, preserve, and exhibit materials of history, and to spread historical information, concerning the North Miami area; and

WHEREAS, the City of North Miami ("City") has provided on-site storage for the historical materials and artifacts acquired by the Historical Society within its buildings and facilities; and

WHEREAS, the City and the Historical Society are desirous of entering into an agreement to delineate the responsibilities of each party regarding the ownership, storage, and maintenance of the materials stored at City facilities; and


WHEREAS, the Mayor and City Council find that entering into an Agreement with the Historical Society for this purpose is beneficial and in the best interest of the City.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Authority of the Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and City Attorney to negotiate and execute an Ownership, Storage, and Maintenance of Materials Agreement with the Greater North Miami Historical Society, Inc., to provide for the storage of historical materials and artifacts in City facilities.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
