

RESOLUTION NO. 2024-R-125

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA APPROVING THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY FISCAL YEAR 2023-2024 AMENDED BUDGET; AUTHORIZING THE CITY MANAGER TO TRANSMIT THE CRA FISCAL YEAR 2023-2024 AMENDED BUDGET TO MIAMI-DADE COUNTY; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTION NECESSARY TO COMPLETE THE APPROVAL PROCESS FOR THE CRA FISCAL YEAR 2023-2024 AMENDED BUDGET WITH MIAMI-DADE COUNTY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Interlocal Cooperation Agreement between the North Miami Community Redevelopment Agency (the “CRA”), the City of North Miami (the “City”) and Miami-Dade County (the “County”) requires, among other things, the CRA to annually adopt and transmit a budget and annual report to the City and County for review and approval by the City Council and Board of County Commissioners (the “BCC”), respectively; and

WHEREAS, the CRA Fiscal Year 2023-2024 Budget was previously approved by the CRA and the City; and

WHEREAS, the CRA desires to amend the CRA Fiscal Year 2023-2024 Budget in certain respects; and

WHEREAS, the amended Fiscal Year 2023-2024 Budget for the CRA is attached hereto as Exhibit “A” (the “CRA Fiscal Year 2023-2024 Amended Budget”); and

WHEREAS, the CRA previously approved the CRA Fiscal Year 2023-2024 Amended Budget; and

WHEREAS, the Mayor and City Council desire to approve the CRA Fiscal Year 2023-2024 Amended Budget.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Recitals. The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.


Section 2. Approval. The CRA Fiscal Year 2023-2024 Amended Budget attached hereto as Exhibit “A” is hereby approved and adopted.

Section 3. Transmittal. The Interim City Manager is hereby authorized to transmit the CRA Fiscal Year 2023-2024 Amended Budget to the County for review and approval.

Section 4. Authorization of Interim City Manager. The Interim City Manager is hereby authorized to take all actions necessary to complete the approval process for the CRA Fiscal Year 2023-2024 Amended Budget with the County.


Section 5. Effective Date. This Resolution shall take effect immediately upon approval.
