

RESOLUTION NO. 2024-R-127

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING RESOLUTION NO. 2023-R-233 TO REFLECT LEGALADS.MIAMIDADE.GOV TO BE THE PUBLICLY ACCESSIBLE WEBSITE UTILIZED BY THE CITY OF NORTH MIAMI FOR PUBLICATION OF CITY LEGAL ADVERTISEMENTS AND PUBLIC NOTICES AS AN ALTERNATIVE TO NEWSPAPER PUBLICATION, AS AUTHORIZED BY FLORIDA STATUTE SECTION 50.0311; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on December 12, 2023, the Mayor and City Council adopted Resolution No. R-2023-R-223, authorizing the online publication of City legal advertisements and public notices on Miami-Dade County's publicly accessible website in accordance with section 50.0311 of the Florida Statutes; and

WHEREAS, Resolution No. 2023-R-233 listed the publicly designated website address to be www.realauction.com; and

WHEREAS, on July 16, 2024, the Miami-Dade County Commission adopted Resolution No. R-693-24 designating legalads.miamidade.gov to be Miami-Dade County's publicly accessible website for publication of legal advertisements and public notices; and

WHEREAS, the Mayor and City Council wish to amend Resolution No. 2023-R-233 to reflect the website address of legalads.miamidade.gov to be the website address utilized by the City of North Miami for publication of its legal advertisements and public notices, in accordance with Florida Statute section 50.0311; and

WHEREAS, the Mayor and City Council find that the adoption of this amendment is in the best interest of the City and its residents.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Recitals. That each of the above-stated recitals is hereby adopted, confirmed, and incorporated herein.

Section 2. **Amendment.** The Mayor and City Council hereby amend Resolution No. 2023-R-233 to reflect the website address of legalads.miamidade.gov to be the website address utilized by the City of North Miami for publication of its legal advertisements and public notices, in accordance with Florida Statute section 50.0311.

Section 3. **Effective Date.** This Resolution shall be effective immediately upon adoption.
