

RESOLUTION NO. 2024-R-129

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE EXECUTION OF AN
INTERGOVERNMENTAL AGENCY AGREEMENT
BETWEEN THE CITY OF NORTH MIAMI AND MIAMI-
DADE COUNTY TO PROVIDE FOR THE PERFORMANCE
OF CERTAIN TRAFFIC ENGINEERING FUNCTIONS;
PROVIDING FOR AN EFFECTIVE DATE AND ALL
OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”), is desirous of entering into an Intergovernmental Agency Agreement with Miami-Dade County to provide for the performance of certain traffic engineering functions; and

WHEREAS, pursuant to Section 2-96.1 of the Miami-Dade County Code, all traffic control and traffic engineering services in Miami-Dade County are under the exclusive jurisdiction of the County; and

WHEREAS, the City desires to assume the installation and maintenance responsibilities of certain additional traffic engineering functions pertaining to its local municipal streets only and has requested the County to allow it to perform the function of conducting engineering studies for the feasibility of traffic calming devices and installing traffic calming devices; and

WHEREAS, the City’s Public Works Department has represented to the County that it is capable, equipped, and qualified to perform the duties and functions requested herein; and

WHEREAS, on June 24, 2014, the City of North Miami Mayor and City Council adopted Resolution No. 2014-R-50 approving an Intergovernmental Agency Agreement to allow the City to perform traffic engineering functions; and

WHEREAS, the parties are desirous of entering into an updated agreement that will replace the “INTERGOVERNMENTAL AGENCY AGREEMENT TO PERFORM TRAFFIC ENGINEERING FUNCTIONS” previously entered into on July 30, 2014; and


WHEREAS, the Mayor and City Council deem it to be in the best interests of the City and its residents to authorize the execution of the Intergovernmental Agency Agreement providing for the performance of certain traffic engineering functions.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Authority.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the execution of the Intergovernmental Agency Agreement with Miami-Dade County, in substantially the form attached hereto as Exhibit "A", to provide for the performance of certain traffic engineering functions.

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
