

RESOLUTION NO. 2024-R-134

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS TO GALLS, LLC, IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000.00), FOR AN ON-LINE WEB-BASED UNIFORMS AND EQUIPMENT ORDERING SYSTEM FOR THE CITY OF NORTH MIAMI POLICE DEPARTMENT, UTILIZING BROWARD SHERIFF'S OFFICE CONTRACT NO. SHERIFF RLI# 23013AG, PURSUANT TO SECTION 7-167 OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, Broward Sheriff's Office ("BSO") issued *Solicitation No. RLI# 23013AG* seeking a qualified candidate to provide all services necessary to provide and maintain a presence on-site and an on-line web-based ordering system for uniforms and accessories per the terms, conditions, and specifications contained in the Solicitation; and

WHEREAS, Galls, LLC was selected by BSO as the highest qualified firm to provide the aforementioned services for a term of three (3) years (through August 16, 2026) with five (5) options to renew for additional one (1) year terms; and

WHEREAS, Section 7-167 of the City of North Miami ("City") Code of Ordinances authorizes the City Manager to approve the purchase of supplies, goods, and/or services from current agreements of other municipalities and governmental entities, such as Broward Sheriff's Office; and

WHEREAS, City administration respectfully requests approval to use BSO's contract, procured under *RLI No. 23013AG*, for the provision of an online web-based ordering system for police uniforms and accessories, in an estimated amount not to exceed One Hundred Twenty Thousand Dollars (\$120,000.00); and

WHEREAS, the Mayor and City Council find that the provision of an on-line web-based ordering system for uniforms and accessories is in the best interest of the City.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue Purchase Orders to Galls, LLC for an on-line web-based uniforms and equipment ordering system for the City of North Miami Police Department, at an estimated cost not to exceed One Hundred Twenty Thousand Dollars (\$120,000.00), under Broward Sheriff's Office Contract No. SHERIFF RLI# 23013AG, pursuant to Section 7-167 of the Code of Ordinances.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
