

RESOLUTION NO. 2024-R-167

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION, TO SECURE A FLORIDA RECREATION DEVELOPMENT ASSISTANCE PROGRAM GRANT IN SUPPORT OF THE ROTARY OVERBROOK TOT-LOT AT ALHAMBRA HEIGHTS REHABILITATION PROJECT; PROVIDING FOR AN EFFECTIVE DATE, AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of securing a grant from the Florida Department of Environmental Protection (“FDEP”) Recreation Development Assistance Program; and

WHEREAS, the City of North Miami (“City”) requested a grant in the amount of One Hundred and Twenty Thousand Dollars and No Cents (\$120,000.00) with a required thirty percent (30%) match in the amount of Thirty Thousand Dollars and No Cents (\$30,000.00) for a total project cost in the amount of One Hundred and Fifty Thousand Dollars and No Cents (\$150,000.00); and

WHEREAS, funds will be used toward the rehabilitation of the Rotary Overbook Tot-Lot at Alhambra Heights; and

WHEREAS, the grant will fund key improvements to the park, including resurfacing the play area, replacing fencing, and installing new playground equipment, benches, picnic tables, and landscaping enhancements; and

WHEREAS, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the Florida Department of Environmental Protection.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Ratification of Submittal of Application. The Mayor and City Council hereby ratify the submittal of the City of North Miami's application for a grant from the Florida Department of Environmental Protection in support of the City's rehabilitation of the Rotary Overbrook Tot-Lot at Alhambra Heights.

Section 2. Authority to Interim City Manager and City Attorney. The Interim City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida, and the Florida Department of Environmental Protection to obtain grant funds.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
