

RESOLUTION NO. 2024-R-187

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE INTERIM CITY MANAGER TO
ISSUE PURCHASE ORDERS, IN AN AGGREGATE
AMOUNT NOT TO EXCEED EIGHT HUNDRED FORTY
THOUSAND DOLLARS (\$840,000.00) ANNUALLY, FOR
THE PROVISION OF SERVICES RELATED TO
CONCRETE CURBING, SIDEWALK CONSTRUCTION,
MILLING AND RESURFACING OF ASPHALT
CONCRETE, STRIPING OF CITY STREETS AND LANE
DELINEATORS, ON AN AS-NEEDED BASIS, UTILIZING
THE CITY OF DANIA BEACH ITB NO. 2024-21-0-2024;
PROVIDING FOR AN EFFECTIVE DATE AND ALL
OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”) Public Works Department is desirous of continuing its ongoing operation and maintenance of the City’s rights-of-way by undertaking preventive maintenance including construction and maintenance of concrete curbing, sidewalks, as well frequent roadway milling and resurfacing to ensure traffic safety; and

WHEREAS, City staff has identified the recent award of contracts issued by the City of Dania Beach which can provide the type of services needed on an ongoing basis, by the Public Works Department; and

WHEREAS, on July 11, 2024, the City of Dania Beach issued Invitation to Bid No. 2024-21-0-2024, "Concrete Curbing/Sidewalk Construction, Milling and Resurfacing of Asphalt Concrete, Striping of City Streets and Parking Lots, and Lane Delineators", to address the City’s ongoing need for the rapid repair and maintenance of city streets and parking lots, requiring services such as striping and the installation of lane delineators; and

WHEREAS, on October 7, 2024, the City of Dania Beach adopted Resolution No. 2024-152 awarding contracts to the following companies: FG Construction LLC. Metro Express Inc.. The Stout Group LLC and Weekley Asphalt Paving, Inc (“Vendors”); and

WHEREAS, in accordance with Section 7-167 of the City Code, the City administration may purchase supplies or services from current contracts of other governmental agencies, with City Council approval on any such purchase which exceeds Thirty Thousand Dollars (\$30,000.00); and

WHEREAS, the City administration desires to utilize the existing agreements between the City of Dania Beach and Vendors, to obtain competitive pricing; and

WHEREAS, City administration respectfully requests approval to use the City of Dania Beach's contracts for the issuance of Purchase Orders, in an amount not to exceed the aggregate amount of Eight Hundred Forty Thousand Dollars and 00/100 (\$840,000.00) to purchase services related to rights-of-way maintenance; and

WHEREAS, the Mayor and City Council find that the purchase of services, in accordance with the Solicitation, is in the best interest of the City.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue purchase orders, in an aggregate amount not to exceed Eight Hundred Forty Thousand Dollars and 00/100 (\$840,000.00) annually, for the provision of services related to concrete curbing, sidewalk construction, milling and resurfacing of asphalt concrete, striping of city streets and lane delineators, utilizing City of Dania Beach ITB No. 2024-21-0-2024, pursuant to section 7-167 of the Code of Ordinances.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
