

RESOLUTION NO. 2024-R-186

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING AN AMENDMENT TO THE FISCAL YEAR 2024-2025 CAPITAL IMPROVEMENT BUDGET TO INCLUDE \$1.5 MILLION DOLLARS TO BE UTILIZED TOWARD THE CLAUDE PEPPER PARK REDEVELOPMENT PROJECT IN SUPPORT OF THE LAND AND WATER CONSERVATION FUND (“LWCF”) GRANT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council of the City of North Miami passed and adopted an annual budget in accordance with the Charter of the City of North Miami (“City”) for Fiscal Year 2024-2025, commencing on October 1, 2024; and

WHEREAS, the City is desirous of completing the Claude Pepper Park Redevelopment project as part of the Land and Water Conservation Fund (“LWCF”) Grant, requiring an adjustment to be made to the Capital Improvement Budget of the current Fiscal Year; and

WHEREAS, the Mayor and City Council desire to amend the Fiscal Year 2024-2025 Capital Improvement Budget, to include \$1.5 Million Dollars to be utilized toward the Claude Pepper Park Redevelopment Project in support of the LWCF Grant.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Amendment of Budget. The Mayor and City Council of the City of North Miami, Florida, hereby approve an amendment to the Fiscal Year 2024-2025 Capital Improvement Budget to include to include \$1.5 Million Dollars to be utilized toward the Claude Pepper Park Redevelopment Project in support of the Land and Water Conservation Fund (“LWCF”) Grant.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
