

RESOLUTION NO. 2024-R-183

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF TRANSPORTATION, TO SECURE A TRANSPORTATION ALTERNATIVES PROGRAM PLANNING GRANT IN SUPPORT OF THE NORTH MIAMI DOWNTOWN MICRO-MOBILITY PLAN; PROVIDING FOR AN EFFECTIVE DATE, AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of securing a grant from the Florida Department of Transportation (“FDOT”) Transportation Alternatives Program (“TAP”) grant; and

WHEREAS, the City of North Miami (“City”) is requesting a grant in the amount of Two Hundred and Fifty Thousand Dollars and No Cents (\$250,000.00) with no required match; and

WHEREAS, funds will be used toward the development of the North Miami Downtown Micro-Mobility Plan; and

WHEREAS, the grant will fund the development of a micro-mobility plan focusing on assessing critical downtown areas suitable for micro-mobility access and connectivity, planning for infrastructure facilitating safe and accessible micro-mobility travel, and evaluating requirements for dedicated paths, secure parking, and connectivity with already existing transit options in the downtown area; and

WHEREAS, the Mayor and City Council wish to authorize the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the Florida Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:


Section 1. Authorization for Submittal of Application. The Mayor and City Council hereby authorize the submittal of the City of North Miami’s application for a grant from the Florida Department of Transportation in support of the City’s Downtown Micro-Mobility Plan.

Section 2. Authority to Interim City Manager and City Attorney. The Interim City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between

the City of North Miami, Florida and the Florida Department of Transportation to obtain grant funds.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
