

RESOLUTION NO. 2024-R-180

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE INTERIM CITY MANAGER TO
ISSUE PURCHASE ORDERS TO US LUBRICANTS, LLC
AND ENVIROWASTE SERVICES GROUP, INC., IN AN
AGGREGATE AMOUNT NOT TO EXCEED ONE
HUNDRED THOUSAND DOLLARS (\$100,000.00)
ANNUALLY, FOR THE PROVISION OF STORMWATER
MAINTENANCE SERVICES, UTILIZING THE CITY OF
AVVENTURA RFP NO. 2024-7-1; PROVIDING FOR AN
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”) Public Works Department is desirous of continuing its ongoing operation and maintenance of the City’s stormwater maintenance system; and

WHEREAS, City staff has identified the recent award of contracts issued by the City of Aventura for the provision of stormwater maintenance services which includes, but is not limited to, stormwater catch basins, inlets, manholes, pipes, outfalls, and pollution control devices; and

WHEREAS, on July 9, 2024, the City of Aventura issued Request for Proposals No. 2024-7-1 requesting proposals from qualified and experienced firms to provide labor, supervision, equipment, supplies, tools, permitting, maintenance of traffic, safety measures and all other necessary incidentals for continuing services for the vacuum cleaning/jetting and inspection of, and emergency response to, CITY owned stormwater infrastructure system, in accordance with the terms, conditions, and specifications contained in the Solicitation; and

WHEREAS, on September 3, 2024, the City of Aventura adopted Resolution No. 2024-54 awarding contracts to US Lubricants, LLC and Envirowaste Services Group, Inc. (“Vendors”) as the top two (2) highest-ranked Contractors; and

WHEREAS, in accordance with Section 7-167 of the City Code, the City administration may purchase supplies or services from current contracts of other governmental agencies, with City Council approval on any such purchase which exceeds Thirty Thousand Dollars (\$30,000.00); and

WHEREAS, the City administration desires to utilize the existing Agreement between the City of Aventura and Vendors, to obtain competitive pricing; and

WHEREAS, City administration respectfully requests approval to use the City of Aventura's contracts for the issuance of Purchase Orders, in an amount not to exceed the aggregate amount of One Hundred Thousand Dollars and 00/100 (\$100,000.00) annually to purchase services related to maintenance of the City's stormwater system; and


WHEREAS, the Mayor and City Council find that the purchase of services, in accordance with the Solicitation, is in the best interest of the City.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue purchase orders to US Lubricants, LLC and Envirowaste Services Group, Inc., in an aggregate amount not to exceed One Hundred Thousand Dollars and 00/100 (\$100,000.00) annually, for the provision of stormwater maintenance services, utilizing City of Aventura RFP No. 2024-7-1, pursuant to section 7-167 of the Code of Ordinances.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
