

**RESOLUTION NO. 2024-R-172**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA AMENDING RESOLUTION NUMBERS R-2024-R-162 AND R-2024-164 TO REFLECT UPDATED ELECTION RESULTS OF THE REGULAR ELECTION FOR THE OFFICES OF MAYOR AND DISTRICT 4 COUNCILPERSON FOR THE CITY OF NORTH MIAMI, HELD ON NOVEMBER 5, 2024, AS A RESULT OF THE RECOUNT CONDUCTED BY THE MIAMI-DADE CANVASSING BOARD ON NOVEMBER 12, 2024; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, on November 12, 2024, the Mayor and City Council adopted Resolution Numbers R-2024-R-162 and R-2024-164, canvassing the returns and certifying the results of the election for the office of Mayor of the City of North Miami and District 4 Councilperson, held on November 5, 2024; and

**WHEREAS**, in accordance with Sections 102.141(7) and 102.166, Florida Statutes, an automatic recount of the votes cast for Mayor and Councilperson - District 4, in the November 5, 2024, North Miami Regular Election was conducted on November 12, 2024, by the Miami-Dade Canvassing Board; and

**WHEREAS**, as a result of the recount, the Miami-Dade County Canvassing Board provided updated election results as indicated in the Certificate of County Canvassing Board attached as Exhibit "A"; and

**WHEREAS**, the Mayor and City Council are desirous of amending Resolution Numbers R-2024-162 and R-2024-164 to reflect the updated election results provided by the Miami-Dade County Canvassing Board.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Updated Election Results (Mayor).** That the Mayor and City Council of the City of North Miami, Florida, have found that 19,652 valid votes were cast for the office of Mayor as follows:

3,568 votes for NAOMI ESTHER BLEMUR

4,408 votes for DAPHNE CAMPBELL

7,226 votes for ALIX DESULME

4,450 votes for HECTOR MEDINA

**Section 1. Updated Election Results (District 4 Councilperson).** That the Mayor and City Council of the City of North Miami, Florida, have found that 6,307 valid votes were cast for the office of District 4 Councilperson as follows:

1,036 votes for DANIEL CALIXTE

1,020 votes for CHARLIE NACIVRE CHARLES


2,777 votes for PIERRE FRANTZ CHARLES
