

RESOLUTION NO. 2024-R-196

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
CANVASSING THE RETURNS AND CERTIFYING THE
RESULTS OF A RUN-OFF ELECTION FOR
COUNCILPERSON FOR DISTRICT NO. 1 IN THE CITY
OF NORTH MIAMI, HELD ON DECEMBER 3, 2024;
PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, on November 28, 2023, the Mayor and City Council of the City of North Miami, Florida ("City"), pursuant to Article III, Section 10, Article VII, Section 36, and Article VIII, Section 58 of the City of North Miami Charter ("City Charter"), passed and adopted Resolution No. 2023-R-218, calling for an election to be held on November 5, 2024, with any necessary runoff election to be held on November 26, 2024, for the Mayor, two (2) Council members, one (1) for Council District No. 1 and one (1) for Council District No. 4, and the City Clerk of the City of North Miami, in accordance with the City Charter and Code of Ordinance provisions; and

WHEREAS, the Miami-Dade County Elections Department advised that the November 26, 2024, runoff election date was unavailable as the Department requires a specific post-General Election timeline to conduct potential statewide, county, or municipal recount(s), certify election results as well as post-election audit functions/reports as mandated by Florida Statutes; and

WHEREAS, on January 23, 2024, the Mayor and City Council adopted Resolution No. 2024-R-4 establishing December 3, 2024, as the run-off election date for the 2024 regular election; and

WHEREAS, the run-off election was held on December 3, 2024; and

WHEREAS, pursuant to law, the results of that election are to be canvassed and certified by the City Council.

**NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

Section 1. **Canvassing Returns.** That the Mayor and City Council has publicly canvassed the returns of the election of December 3, 2024, and has found that 1,348 total ballots were cast at the election for Councilperson for District No. 1.


Section 2. **Election Results.** That the Mayor and City Council has found that valid votes were cast for the office of Councilperson for District No. 1 as follows:

849 votes for KEVIN A. BURNS

499 votes for VANESSA PIERRE

Section 3. **Canvassing Board Findings.** The Canvassing Board has found that KEVIN A. BURNS has received the highest number of votes for the office of Councilperson for District No. 1, and that KEVIN A. BURNS is declared elected and shall hold office as Councilperson for District No. 1 for a term of four (4) years, pursuant to the City Charter.
