

RESOLUTION NO. 2025-R-6

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING A SETTLEMENT IN THE AMOUNT OF EIGHTY-TWO THOUSAND FIVE HUNDRED DOLLARS (\$82,500.00) IN THE LITIGATION MATTER OF RAYNELL HODGE VS JEAN LAFALAISE FABRE AND CITY OF NORTH MIAMI, ET. AL., CASE NO.: 2023-008959-CA-01; FURTHER AUTHORIZING THE EXECUTION OF A SETTLEMENT AGREEMENT FOR THE FULL AND FINAL SETTLEMENT OF ALL CLAIMS AND DEMANDS IN CONNECTION WITH THIS ACTION; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on March 21, 2023, a lawsuit was filed against the City of North Miami (“City”), styled as *Raynell Hodge vs. Jean LaFalaise Faber, City of North Miami, et. al.*, Case Number: 2023-008959-CA-01 alleging automobile negligence; and

WHEREAS, the parties entered into pre-trial settlement discussions, and as a result of successful negotiations, resolved all outstanding issues in the litigation; and

WHEREAS, after being fully advised of the legal and related issues, the Mayor and City Council believe it is in the best interest of the City to authorize a Settlement Agreement with Raynell Hodge for the full resolution of the outstanding claims.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Recitals. The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.



Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.


