

RESOLUTION NO. 2025-R-9

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE INTERIM CITY MANAGER AND
CITY ATTORNEY TO EXECUTE AN AGREEMENT FOR
PROFESSIONAL SERVICES, BETWEEN THE CITY OF
NORTH MIAMI AND THE SOUTHERN GROUP OF
FLORIDA, INC., TO PROVIDE THE CITY WITH
GOVERNMENTAL AFFAIRS AND LOBBYING SERVICES
AT A MONTHLY COST NOT TO EXCEED SIX
THOUSAND SIX HUNDRED SEVENTY DOLLARS
(\$6,670.00); WAIVING COMPETITIVE BIDDING IN
ACCORDANCE WITH SECTION 7-120(B) OF THE NORTH
MIAMI CODE OF ORDINANCES; AND PROVIDING FOR
AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”) desires to contract for the professional services of The Southern Group of Florida, Inc. for the provision of governmental affairs and lobbying services (“Services”); and

WHEREAS, these services will include: drafting processes and procedures to create annual legislative priorities for the Council’s approval, coordinating with local, state, and federal lobbyists to compile session timetables and priorities deadlines for effective lobbying, collaborating with the City Manager and Mayor & Council’s office to gather priorities, create an evaluation process to determine the effectiveness of lobbyists’ work and priorities, create a format for appropriate legislative policies “talking points” for Mayor and council to use, provide consulting services to the City regarding lobbying protocols, process, and procedures, and when possible, meeting with state and local legislators, members of their staff and departments; and

WHEREAS, Services will be provided at a cost not to exceed six thousand six hundred seventy dollars (\$6,670.00) per month; and

WHEREAS, it is respectfully requested that the Mayor and City Council authorize the City Manager to execute an agreement for professional services with The Southern Group of Florida, Inc.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Waiver. The Mayor and City Council of the City of North Miami, Florida, hereby waive competitive bidding procedures in accordance with Section 7-120(b) of the Procurement Code.

Section 2. Authority of Interim City Manager and City Attorney. The Interim City Manager and City Attorney are hereby authorized to execute an agreement for professional services, between the City of North Miami and The Southern Group of Florida, Inc., providing for coordination of the City's legislative relations and for lobbying requirements at a monthly cost not to exceed six thousand six hundred seventy dollars (\$6,670.00).


Section 3. Effective Date. This Resolution shall be effective upon adoption.
