

**RESOLUTION NO. 2025-R-2**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, CLAUDIA  
PAZMINO TO THE NORTH MIAMI PARKS AND  
RECREATION COMMISSION, TERM ENDING ON  
NOVEMBER 07, 2028, IN ACCORDANCE WITH CHAPTER  
2, ARTICLE III, DIVISION 5, SECTION 2-187, OF THE CITY  
OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING  
FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the purpose of the North Miami Parks and Recreation Commission is to: prepare and recommend a comprehensive master plan for the park and recreation services and needs, review and evaluate the parks and recreation department annual budget and capital improvement proposals, serve in a liaison capacity between the public and the city council, and serve as a public relations interface to the general public; and

**WHEREAS**, Chapter 2, Article III, Division 5, Section 2-187, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint two (2) members to the Parks and Recreation Commission; and

**WHEREAS**, appointees shall reside in the City of North Miami and shall not be an employee of the city, in accordance with Section 2-186 of the City Code; and

**WHEREAS**, Councilman Kevin Burns desires to appoint Claudia Pazmino to the North Miami Parks and Recreation Commission.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

**Section 2.      Appointments.** The Mayor and City Council of the City of North Miami, Florida, hereby appoint Claudia Pazmino to the North Miami Parks and Recreation Commission.

**Section 3.      Effective Date.** This Resolution shall become effective immediately upon adoption.
