

RESOLUTION NO. 2025-R-33

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS TO CDW GOVERNMENT, LLC, IN AN AGGREGATE AMOUNT NOT TO EXCEED TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000.00), FOR THE PURCHASE OF COMPUTER HARDWARE, SOFTWARE, AND PERIPHERALS, UTILIZING THE COOPERATIVE PURCHASING PROVISION PURSUANT TO SEC. 7-169 OF THE CITY CODE ON A CONTRACT AWARDED THROUGH SOURCEWELL REQUEST FOR PROPOSALS NO. 121923; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, On December 19, 2023, Sourcewell, a national purchasing cooperative, issued a competitive solicitation titled *Request For Proposals No. 121923 - Technology Products and Services with Related Solutions* seeking proposals from experienced and qualified vendors to enter into a national cooperative contract made available to over 50,000 government, educational and non-profit member agencies, which includes the City of North Miami ("City"); and

WHEREAS, as a result of this Solicitation, CDW Government, LLC ("CDW") was deemed to be the top-ranked company and was awarded a contract by Sourcewell which runs through February 27, 2028, and allows up to three (3) additional one (1) year extensions upon the request of Sourcewell and written agreement by the Supplier; and

WHEREAS, the City's Information Technology department has requested the purchase of computer hardware and software available through the CDW contract, as needed on an ongoing basis; and

WHEREAS, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

WHEREAS, in accordance with Section 7-169 of the City Code, the City administration respectfully requests that the Mayor and City Council authorize the Interim City Manager to issue purchase orders to CDW for the provision of computer hardware, software, and peripherals, on an infrastructure as needed and ongoing basis in an amount not to exceed Two Hundred Fifty Thousand Dollars (\$250,000.00), based on a competitive price to the City; and


WHEREAS, the Mayor and City Council find the cooperative purchase of computer equipment at a substantial savings is in the best interest of the City.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue purchase orders to CDW Government, LLC in the aggregate amount not to exceed Two Hundred Fifty Thousand Dollars (\$250,000.00), utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
