

RESOLUTION NO. 2025-R-31

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE INTERIM CITY MANAGER TO
EXECUTE A CLIENT SERVICES AGREEMENT WITH
PEANUT BUTTER INC., TO PROVIDE STUDENT LOAN
REPAYMENT SERVICES FOR THE 2025-2026 PLAN
YEAR; FURTHER AUTHORIZING THE INTERIM CITY
MANAGER TO EXECUTE ALL NECESSARY
DOCUMENTS TO EFFECTUATE SAID PROGRAM;
PROVIDING FOR AN EFFECTIVE DATE AND ALL
OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”) is desirous of offering student loan repayment services to its employees for the 2025-2026 plan year; and

WHEREAS, City Staff recommends that the student loan repayment services be provided by Peanut Butter Inc., a Delaware corporation, effective on January 28, 2025; and

WHEREAS, the City has negotiated through its Agent of Record to elect Peanut Butter, Inc.’s services; and

WHEREAS, Peanut Butter Inc.’s Representatives have met with the Agent of Record to conduct an in-depth comparison and analysis of the available service offerings; and

WHEREAS, the City Administration has negotiated through its Agent of Record to adapt the comprehensive service offerings; and

WHEREAS, the City Administration respectfully recommends that the City contract with Peanut Butter Inc. to provide student loan repayment services to; and

WHEREAS, the Mayor and City Council find that it is in the City’s best interests to authorize the Interim City Manager to execute a Client Service Agreement with Peanut Butter Inc. for the provision of services; and

WHEREAS, the Mayor and City Council find the execution of the student loan repayment program with Peanut Butter Inc. for the 2025-2026 plan year to be in the best interest of the City.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to execute a Client Services Agreement for the provision of student loan repayment services, in the substantially the form attached as Exhibit "A", as well as all necessary documents to effectuate said program.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
