**RESOLUTION OF THE MAYOR AND CITY COUNCIL OF  
THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING  
THE INTERIM CITY MANAGER TO EXECUTE AN  
AFFILIATING AGREEMENT FOR EDUCATIONAL  
SERVICES WITH THE MIAMI-DADE COUNTY PUBLIC  
SCHOOLS' NORTH MIAMI ADULT EDUCATION  
CENTER, IN SUBSTANTIALLY THE ATTACHED FORM,  
FOR THE PROVISION OF EDUCATIONAL INSTRUCTION  
FOR ENGLISH FOR SPEAKERS OF OTHER LANGUAGES  
("ESOL"); PROVIDING FOR AN EFFECTIVE DATE AND  
ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami Public Library and the School Board of Miami-Dade County's North Miami Adult Education Center seek to provide off-campus educational resources and instruction for the English for Speakers of Other Languages ("ESOL") program; and

**WHEREAS**, under the terms of the proposed Affiliating Agreement for Educational Services, North Miami Adult Education Program will provide qualified ESOL instructors, and the North Miami Public Library will provide a classroom, electricity, furniture, and access to telephone services; and

**WHEREAS**, the Mayor and City Council believe that entering into an Agreement for this purpose will benefit the residents of the City and should be entered into with the School Board of Miami-Dade County's North Miami Adult Education Center.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Approval.** The Mayor and City Council hereby approve the Affiliating Agreement for Educational Services with the Miami-Dade County Public Schools' North Miami Adult Education Program, in substantially the form attached as Exhibit "A".

**Section 2. Authority of Interim City Manager.** The Interim City Manager is hereby authorized to execute the Affiliating Agreement for Educational Services.

**Section 3. Effective Date.** This Resolution shall be effective upon adoption.
