**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
APPOINTING KAREN DELEON TO GROUP B OF THE  
PERSONNEL BOARD, TERM ENDING ON NOVEMBER 07,  
2028, IN ACCORDANCE WITH CHAPTER 15, ARTICLE 1,  
SECTION 15-4, OF THE CITY OF NORTH MIAMI CODE OF  
ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS**, the Personnel Board shall consist of six (6) members who shall be a qualified voter of the city and shall be known to be in sympathy with the merit principle as applied to the civil service; and

**WHEREAS**, Councilman Kevin A. Burns desires to appoint Karen Deleon to Group B of the Personnel Board.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

**Section 2.      Appointments.** The Mayor of the City of North Miami, Florida, hereby re-appoints Karen Deleon to Group C of the Personnel Board.
