

RESOLUTION NO. 2025-R-21

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RE-APPOINTING ROBIN TISDAHL AT-LARGE TO THE NORTH MIAMI EDUCATION RELATIONS BOARD, TERM ENDING ON NOVEMBER 03, 2026, IN ACCORDANCE RESOLUTION NO. 2022-R-55; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Education Relations Board is dedicated to the topic of education and meets regularly to discuss issues specific to schools within the North Miami feeder pattern; and

WHEREAS, pursuant to Resolution No. 2022-R-55, the Board shall consist of five (5) members appointed at-large for a term of two (2) years; and

WHEREAS, in addition, representatives of Florida International University, Miami Dade College, Barry University, and Miami-Dade Public Schools for schools falling within the North Miami feeder pattern shall have membership on the Board; and

WHEREAS, Councilman Kevin Burns desires to re-appoint Robin Tisdahl at-large to the North Miami Education Relations Board.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Recitals. The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

Section 2. Appointments. The Mayor and City Council of the City of North Miami, Florida, hereby re-appoint Robin Tisdahl at-large to the North Miami Education Relations Board.
