

RESOLUTION NO. 2025-R-41

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPOINTING DOMINQUE PIERRE. ESQ., AT-LARGE TO THE PLANNING COMMISSION, TERM ENDING ON NOVEMBER 07, 2028, IN ACCORDANCE WITH CHAPTER 29, ARTICLE 2, SECTION 2-202, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Planning Commission was created to prepare and make recommendations to the City Council in regards to the comprehensive master plan and land use regulations as well as conduct public hearings in connection with the study of future plans, zoning districts, zoning maps, proposed planned development and conditional uses and make recommendations thereon to the city council; and

WHEREAS, Chapter 29, Article 2, Section 2-202, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint one (1) member to the Planning Commission with two (2) alternates being appointed by the City Council as a whole; and

WHEREAS, Planning Commission appointments shall be chosen from persons with experience in the areas of planning, law, environmental science, the development industry, real estate development, engineering, architecture, former local government officials, and other related local industries, except that the city council may appoint residents who do not satisfy these criteria if no person is available after reasonable search to appoint one person who does, in accordance with Section 2-302(a)(2) of the City Code; and

WHEREAS, Councilman Pierre Frantz Charles desires to appoint Dominique Pierre. Esq., to the Planning Commission as an At-Large member.



Section 2. **Appointment.** The Mayor and City Council of the City of North Miami, Florida, hereby appoints Dominique Pierre. Esq., as an At-Large member of the Planning Commission.
