**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
APPOINTING FARRAH MEME TO THE NORTH MIAMI  
EDUCATION RELATIONS BOARD, TERM ENDING ON  
NOVEMBER 07, 2028, IN ACCORDANCE RESOLUTION  
NO. 2022-R-55; PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS**, in addition, representatives of Florida International University, Miami Dade College, Barry University, and Miami-Dade Public Schools for schools falling within the North Miami feeder pattern shall have membership on the Board; and

**WHEREAS**, Councilman Pierre Frantz Charles desires to appoint Farrah Meme to the North Miami Education Relations Board.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY  
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.
