

RESOLUTION NO. 2025-R-35

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPOINTING FARRAH MEME TO THE ADVISORY COMMITTEE FOR PERSONS WITH SPECIAL NEEDS, TERM ENDING ON NOVEMBER 07, 2028, IN ACCORDANCE WITH CHAPTER 2, ARTICLE III, DIVISION 8, SECTION 2-227, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami Advisory Committee for Persons with Special Needs works in close cooperation with the Miami-Dade County Office of Human Rights and Fair Employment Practices to provide guidance, insight, experience, and expertise on the rights and daily needs of the physically challenged including, but not limited to, as human rights, discrimination, housing, public accommodations, architectural accessibility, employment recreation and such other matters as may seem pertinent and appropriate; and

WHEREAS, Chapter 2, Article III, Division 8, Section 2-227, of the City of North Miami Code of Ordinances, provides that the advisory committee shall have eight (8) members, with the mayor and city council to each appoint one (1) member and with three (3) members to be appointed by the entire mayor and city council; and

WHEREAS, members of the advisory committee shall consist of residents with a strong desire and interest of improving the quality of life of city residents with special needs, as a result of disability; and

WHEREAS, Councilman Pierre Frantz Charles desires to appoint Farrah Meme to the City of North Miami Advisory Committee for Persons with Special Needs.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Recitals. The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.


Section 2. Appointment. The Mayor and City Council of the City of North Miami, Florida, hereby appoint Farrah Meme to the City of North Miami Advisory Committee for Persons with Special Needs.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.


