

**RESOLUTION NO. 2025-R-51**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS FOR THE PURCHASE OF THE FOLLOWING VEHICLES: TWENTY-THREE (23) SPORT UTILITY VEHICLES AND TWO (2) PICK-UP TRUCKS, AT AN AGGREGATE COST NOT TO EXCEED ONE MILLION FIVE HUNDRED SIXTY THOUSAND DOLLARS (\$1,560,000) FROM VARIOUS COMPETITIVELY SELECTED VENDORS, UTILIZING THE COOPERATIVE PURCHASING PROVISION PURSUANT TO SEC. 7-169 OF THE CITY CODE, ON CONTRACTS AWARDED THROUGH THE FLORIDA SHERIFFS ASSOCIATION, UNDER CONTRACT NUMBER FSA24-VEL32.0 AND THE STATE OF FLORIDA DEPARTMENT OF MANAGEMENT SERVICES CONTRACT NO, 23-25100000-ITB; AND DECLARING CERTAIN VEHICLES AND EQUIPMENT AS SURPLUS; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS,** City staff has identified several City vehicles which have exceeded their useful life term, and which require extensive mechanical work to remain part of the City's fleet; and

**WHEREAS,** in accordance with section 7-145 of the North Miami Code of Ordinances, the Purchasing Director recommends that these vehicles be declared as surplus and disposed of in a manner most advantageous to the City; and

**WHEREAS,** the following vehicles and equipment will be purchased to replace the surplus items and to supplement the City's current fleet: Twenty-Three (23) Sport Utility Vehicles and Two (2) Pick-Up Trucks; and

**WHEREAS,** the Florida Sheriffs Association ("FSA") and the State of Florida Department of Management Services offer purchasing contracts for a variety of vehicles, equipment and services that are available for use by eligible agencies, such as the City of North Miami; and

**WHEREAS,** contracts awarded through these cooperative purchasing programs are competitively bid and offer favorable pricing and terms for member agencies to take advantage of; and

**WHEREAS,** Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

**WHEREAS,** in accordance with Section 7-169 of the City Code, the City administration respectfully requests that the Mayor and City Council authorize the Interim City Manager to issue purchase orders to Vendors for the provision of vehicles and equipment in an amount not to exceed One Million Five Hundred Sixty Thousand Dollars (\$1,560,000), based on cooperative purchasing contracts issued by the Florida Sheriffs Association ("FSA") and the State of Florida Department of Management Services, respectively.

**WHEREAS,** the Mayor and City Council find the purchase of the vehicles at a substantial savings, in accordance with the cooperative purchasing contracts, is in the best interest of the City.


**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Declaration of Surplus.** The Mayor and City Council of the City of North Miami, Florida hereby declare the following vehicles and equipment as surplus in accordance with Section 7-145 of the Code of Ordinances: One (1) 2010 Ford Sedan (Police), Three (3) 2010 Dodge Sedans (Police), One (1) 2013 Ford Sport Utility Vehicle (Police), One (1) 2015 Chevrolet Sport Utility Vehicle (City Manager Office), Fifty (15) 2016 Ford Sport Utility Vehicles (Police), and One (1) 2020 Ford Sport Utility Vehicle (Police).

**Section 2. Authority of Interim City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue purchase orders to various vendors, at an aggregate cost not to exceed One Million Five Hundred Sixty Thousand Dollars (\$1,560,000), utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code, for the purchase of Twenty-Three (23) Sport Utility Vehicles and Two (2) Pick-Up Trucks, based on cooperative purchasing contracts issued through the Florida Sheriffs Association ("FSA") and the State of Florida.


**Section 2. Effective Date.** This Resolution shall be effective upon adoption.


