

RESOLUTION NO. 2025-R-50

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY'S BID AWARD OF SPORT SURFACES, LLC, AS THE LOWEST, RESPONSIVE, AND RESPONSIBLE BIDDER TO PERFORM THE PENNY SUGARMAN TENNIS CENTER COURTS RESURFACING PROJECT, IN ACCORDANCE WITH THE TERMS, CONDITIONS, AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 07-24-25; FURTHER AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT, IN AN AMOUNT NOT TO EXCEED TWO HUNDRED SEVENTY THOUSAND SIX HUNDRED DOLLARS (\$270,600.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on October 23, 2024, the City of North Miami ("City") advertised *Invitation for Bid No. 07-24-25 – Re-Surfacing of the Penny Sugarman Tennis Center Courts Project* ("IFB"), soliciting bids from qualified, licensed, and experienced contractors to provide all the necessary labor, materials, equipment and expertise needed for the successful resurfacing of the Penny Sugarman Tennis Center located at 1795 Sans Souci Boulevard, in accordance with the specifications and conditions contained in the IFB (collectively referred hereto as "Services"); and

WHEREAS, in response to the IFB, Sport Surfaces, LLC ("Contractor") submitted its bid and was competitively selected by City administration as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the Contractor has manifested the capability and willingness of providing Services to the City, in accordance with the terms, conditions and specifications contained in the IFB, at a cost not to exceed Two Hundred Seventy Thousand Six Hundred Dollars (\$270,600.00); and

WHEREAS, the Mayor and City Council have determined that it is in the City's best interest to approve the selection of a Contractor and hereby authorize the Interim City Manager and City Attorney to negotiate and execute an agreement for the provision of Services to perform the Penny Sugarman tennis center courts resurfacing project.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Bid Award.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City bid award of Sport Surfaces, LLC, as the lowest, responsive and responsible contractor to perform the Penny Sugarman Tennis Center Courts Resurfacing Project, in accordance with the terms, conditions and specifications contained in *Invitation for Bid No. 07-24-25 – Re-Surfacing of the Penny Sugarman Tennis Center Courts Project.*

Section 2. **Authority of Interim City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and City Attorney to negotiate and execute an agreement for the provision of Services with Sport Surfaces, LLC, at a cost not to exceed Two Hundred Seventy Thousand Six Hundred Dollars (\$270,600.00).

Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
