

RESOLUTION NO. 2025-R-56

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS TO COMPUTERS AT WORK!, INC. D/B/A VTECHIO, IN AN AGGREGATE AMOUNT NOT TO EXCEED SEVENTY-THREE THOUSAND SEVEN HUNDRED NINETY-FOUR DOLLARS (\$73,794.00), FOR THE PURCHASE OF LAPTOP COMPUTERS TO BE USED THROUGHOUT CITY DEPARTMENTS, PURSUANT TO SECTION 7-121(21) OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) Information Technology Department has identified a number of computer systems that need to be replaced to ensure an active system lifecycle with all devices that are running on uniform versions of software and have been updated with the most recent security patches; and

WHEREAS, the IT department recommends the purchase of new laptop computers from Computers At Work!, Inc. d/b/a Vtechio in an aggregate amount not to exceed Seventy-Three Thousand Seven Hundred Ninety-Four Dollars (\$73,794.00); and

WHEREAS, in accordance with Section 7-121(21) of the City Code, the purchase of telecommunications, internet, and cybersecurity services are exempt under the provisions of the Procurement Code; and


WHEREAS, City administration respectfully requests that the Mayor and City Council authorize the issuance of the purchase order, pursuant to Section 7-121(21), City Code of Ordinances.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue Purchase Orders in an aggregate amount not-to-exceed exceed Seventy-Three Thousand Seven Hundred Ninety-Four Dollars (\$73,794.00), to Computers At Work!, Inc. d/b/a Vtechio for the purchase of laptop computers to be utilized throughout City departments, pursuant to Section 7-121(21), City Code of Ordinances.

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
