

RESOLUTION NO. 2025-R-55

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS TO LAN INFOTECH, LLC, IN AN AGGREGATE AMOUNT NOT TO EXCEED EIGHTY-FIVE THOUSAND SEVEN HUNDRED NINETY-FOUR DOLLARS (\$85,794.00) ON AN ANNUAL RECURRING BASIS, FOR THE PURCHASE OF MICROSOFT LICENSES THROUGH THEIR GOVERNMENT COMMUNITY CLOUD SOLUTION PLATFORM, PURSUANT TO SECTION 7-121(21) OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) Information Technology Department has recommended the purchase of Microsoft licenses through their government community cloud solution platform to ensure the IT department maintains its governmental regulation and compliance status; and

WHEREAS, the IT department recommends the purchase of the cloud-based platform from Lan Infotech, LLC in an amount not to exceed Eighty-Five Thousand Seven Hundred Ninety-Four Dollars (\$85,794.00) on an annual recurring basis; and

WHEREAS, in accordance with Section 7-121(21) of the City Code, the purchase of telecommunications, internet, and cybersecurity services are exempt under the provisions of the Procurement Code; and


WHEREAS, City administration respectfully requests that the Mayor and City Council authorize the issuance of the purchase order, pursuant to Section 7-121(21), City Code of Ordinances.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue Purchase Orders in an aggregate amount not-to-exceed exceed Eighty-Five Thousand Seven Hundred Ninety-Four Dollars (\$85,794.00) on an annual recurring basis, to Lan Infotech, LLC for the purchase of Microsoft licenses through their government community cloud solution platform, pursuant to Section 7-121(21), City Code of Ordinances.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
