**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
APPOINTING BRIAN JINKS TO THE SENIOR CITIZENS'
ADVISORY BOARD, TERM ENDING NOVEMBER 07, 2028,
IN ACCORDANCE WITH CHAPTER 2, ARTICLE III,
DIVISION 6, SECTION 2-201, OF THE CITY OF NORTH
MIAMI CODE OF ORDINANCES; PROVIDING FOR AN
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami Senior Citizens' Advisory Board reviews, studies, and sponsors potential and existing local areas for application of any programs as they may relate to senior citizens, reviews and studies welfare programs and recreational facilities as they may relate to and affect senior citizens, and makes recommendations to the city council as it may deem advisable; and

WHEREAS, Chapter 2, Article III, Division 6, Section 2-201, of the City of North Miami Code of Ordinances, provides that the advisory committee shall have a minimum of five (5) members, with each member of the city council nominating one (1) member of the senior citizens' advisory board, all of whom shall be subject to appointment by approval of a majority of the city council; and

WHEREAS, members of the advisory committee shall be residents of the city or associated with a social service agency that benefits elders in the city; and

WHEREAS, Councilman Kevin A. Burns desires to appoint Brian Jinks to the City of North Miami Advisory Committee for Persons with Special Needs.


