

RESOLUTION NO. 2025-R-48

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE A FEDERALLY FUNDED SUBAWARD AND GRANT AGREEMENT, IN SUBSTANTIALLY THE ATTACHED FORM, BETWEEN THE CITY OF NORTH MIAMI AND THE STATE OF FLORIDA DIVISION OF EMERGENCY MANAGEMENT (“FDEM”) TO OBTAIN FEDERAL DISASTER RECOVERY FUNDS; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the State of Florida Department of Emergency Management (“FDEM”) has the statutory authority to disburse federal disaster recovery funds received in response to Hurricane Milton; and

WHEREAS, the City of North Miami (“City”) seeks to obtain federal disaster recovery funds to reimburse eligible expenses incurred by the City in the preparation, response, and post-incident recovery efforts related to Hurricane Milton, including the deployment of police officers to assist other municipalities affected by the storm; and

WHEREAS, by executing the Federally Funded Subaward and Grant Agreement with FDEM, the City will be eligible to access disaster relief funds provided by the Federal Government to recover costs associated with its emergency response operations; and

WHEREAS, the Mayor and City Council find that entering into Federally Funded Subaward and Grant Agreements with FDEM is in the best interest of the City and its residents, ensuring financial recovery for emergency operations and disaster response efforts.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Authority of Interim City Manager. The Mayor and Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to execute a Federally Funded Subaward and Grant Agreement, in substantially the form attached as Exhibit “A”, between the City of North Miami and the State of Florida Department of Emergency Management (“FDEM”), to obtain federal disaster recovery funds for the City of North Miami.

Section 2. Effective Date. This Resolution shall become effective immediately upon


adoption.
