

**RESOLUTION NO. 2025-R-82**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE INTERIM CITY MANAGER'S EMERGENCY PROCUREMENT AND ISSUANCE OF PURCHASE ORDERS TO CROM COATINGS AND RESTORATIONS D/B/A CROM, LLC, IN THE AMOUNT OF ONE HUNDRED SIXTY-SEVEN THOUSAND SIX HUNDRED THIRTY DOLLARS (\$167,630.00), FOR THE REPAIRS NEEDED TO PUMP STATION "G" LOCATED AT 143 STREET AND NORTHEAST 15 AVENUE, PURSUANT TO SECTION 7-144 OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami ("City") public works department recently identified that the wall structure, sewage containment, and pipes at Pump Station "G" are severely deteriorating, making the station unsafe for proper servicing; and

**WHEREAS**, Section 7-144, City Code, allows the City Manager to make emergency procurements when there exists an immediate threat to public health, welfare, or safety or to prevent or minimize serious disruption of government services; and

**WHEREAS**, in order to complete the repairs in an expeditious manner, City staff conferred with Crom Coatings and Restorations d/b/a Crom, LLC to obtain a proposal for the necessary emergency repairs; and

**WHEREAS**, the cost for completion of the necessary services was One Hundred Sixty-Seven Thousand Six Hundred Thirty Dollars (\$167,630.00); and

**WHEREAS**, City administration respectfully requests that the Mayor and City Council ratify the Interim City Manager's issuance of the purchase order, pursuant to Section 7-144, City Code of Ordinances.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Ratification.** The Mayor and City Council of the City of North Miami, Florida, hereby ratify the Interim City Manager's emergency procurement and issuance of a Purchase Order in the amount of One Hundred Sixty-Seven Thousand Six Hundred Thirty Dollars (\$167,630.00), to Crom Coatings and Restorations d/b/a Crom, LLC, for the emergency repairs


needed to Pump Station "G" located at 143<sup>rd</sup> Street and N.E. 15<sup>th</sup> Avenue, pursuant to Section 7-144, City Code of Ordinances.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
