

**RESOLUTION NO. 2025-R-79**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
APPOINTING GUERDA G. THEODORE TO THE LIBRARY  
BOARD, TERM ENDING ON NOVEMBER 11, 2028, IN  
ACCORDANCE WITH CHAPTER 16, ARTICLE II,  
SECTION 16-17, OF THE CITY OF NORTH MIAMI CODE  
OF ORDINANCES; PROVIDING FOR AN EFFECTIVE  
DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, subject to supervision by the Interim City Manager, and control by the City Council, the Library Board makes and adopts bylaws, rules, and regulations for their guidance and the use and administration of the library and its facilities, as may be deemed necessary to maintain the usefulness and efficiency of the library, including recommendations regarding library programs and policies, penalties for trespasses or injury to the library grounds, books or other property, or failure to return any books, or for violation of any such bylaw or regulation; and

**WHEREAS**, Chapter 16, Article II, Section 16-17, of the City of North Miami Code of Ordinances, allows each member of the City Council to nominate one (1) member of the library board, which nomination shall be subject to the approval of a majority of the City Council; and

**WHEREAS**, appointees shall reside in the City of North Miami and shall serve without compensation, in accordance with Section 16-17 of the City Code; and

**WHEREAS**, Councilman Pierre Frantz Charles desires to appoint Guerda G. Theodore to the Library Board.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY  
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

**Section 2.      Appointment.** The Mayor and City Council of the City of North Miami, Florida, hereby appoint Guerda G. Theodore to the Library Board.

**Section 3.      Effective Date.** This Resolution shall become effective immediately upon adoption.
