

RESOLUTION NO. 2025-R-90

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE CHILDREN'S TRUST, TO SECURE A COMMUNITY ENGAGEMENT – PROMOTION OF CITIZEN ENGAGEMENT, ADVOCACY, AND LEADERSHIP GRANT; PROVIDING FOR AN EFFECTIVE DATE, AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of securing a Community Engagement and Outreach grant from the Children's Trust; and

WHEREAS, the "Engagement Grant" is offered to eligible non-profit organizations and municipalities and is used to implement activities that bring together children, families, and community members to address key issues impacting our community; and

WHEREAS, the City of North Miami ("City") requested and was awarded a grant in the amount of Ten Thousand Dollars and No Cents (\$10,000.00) with no required match for a total project cost in the amount of Ten Thousand Dollars and No Cents (\$10,000.00); and

WHEREAS, funds will be used to fund the "Girls Who Code @ The Library" program, which is an afterschool art program where middle school students learn computer science, coding, and a variety of topics in the STEM field in partnership with the Girls Who Code non-profit organization; and

WHEREAS, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the Children's Trust.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Ratification of Submittal of Application. The Mayor and City Council hereby ratify the submittal of the City of North Miami's application for a Community Engagement and Outreach grant from the Children's Trust.

Section 2. Authority to Interim City Manager and City Attorney. The Interim City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida, and the Children's Trust to obtain grant funds.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
