

**RESOLUTION NO. 2025-R-89**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPOINTING MICHAEL MCDEARMAID TO THE FLOODPLAIN MANAGEMENT PLANNING COMMITTEE, TERM ENDING NOVEMBER 03, 2026, AS THE REPRESENTATIVE FOR THE IRON MANOR/CENTRAL HOMEOWNERS ASSOCIATION, IN ACCORDANCE WITH RESOLUTION 2009-R-164; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Floodplain Management Planning Committee makes recommendations for Floodplain Planning for the City, in conjunction with the City's National Flood Insurance Program CRS requirements and monitors implementation, and conducts an annual review of the City's Floodplain Management Plan and Public Outreach Strategy; and

**WHEREAS**, pursuant to Resolution 2009-R-164, the Board shall consist of seven (7) members. Four (4) of the members shall be City personnel appointed by the City Manager, and three (3) of the members shall reside within the City's floodplain and be appointed as follows:

- a representative of the Greater North Miami Chamber of Commerce,
- a representative of the Keystone Point Homeowners Association
- a representative of the Iron Manor/Central Homeowners Association

**WHEREAS**, Vice-Mayor Kassandra Timothe desires to appoint Michael McDearmaid to the Floodplain Management Planning Committee to serve as the representative of the Iron Manor/Central Homeowners Association.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

**Section 2.      Appointment.** The Mayor and City Council of the City of North Miami, Florida, hereby appoint Michael McDearmaid to the Floodplain Management Planning Committee to serve as the representative of the Iron Manor/Central Homeowners Association.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
