

RESOLUTION NO. 2025-R-88

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, REMOVING OVIDIO DELEON FROM THE FLOODPLAIN MANAGEMENT PLANNING COMMITTEE, IN ACCORDANCE WITH CHAPTER 2, ARTICLE III, DIVISION 1, SECTION 2-32 OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Floodplain Management Planning Committee makes recommendations for Floodplain Planning for the City, in conjunction with the City's National Flood Insurance Program CRS requirements and monitors implementation, and conducts an annual review of the City's Floodplain Management Plan and Public Outreach Strategy; and

WHEREAS, Chapter 2, Article III, Division 1, Section 2-32, of the City of North Miami Code of Ordinances, provides that appointees may be removed from their appointive position upon motion of the mayor or a member of the council and upon vote of a majority; and

WHEREAS, Committee Member DeLeon is ineligible to serve as a representative of the Irons Manor/Central Homeowners Association as he is not a member of this particular homeowners' association; and

WHEREAS, the Mayor and Council find that it is in the best interest and welfare of the City of North to remove Ovidio DeLeon as a member of the Floodplain Management Planning Committee due to his ineligibility.



Section 2. Removal. The Mayor and City Council of the City of North Miami, Florida, hereby remove Ovidio DeLeon from the Floodplain Management Planning Committee.
