

RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN INTERLOCAL AGREEMENT WITH THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY (“NMCRA”) FOR THE NMCRA TO PROVIDE FUNDING IN THE AMOUNT OF ONE HUNDRED THOUSAND DOLLARS (\$100,000.00) FOR THE FIU CONSTRUCTION TRADES PROGRAM; AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH NMCRA AND FLORIDA INTERNATIONAL UNIVERSITY FOR THE FIU CONSTRUCTION TRADES PROGRAM; AUTHORIZING THE INTERIM CITY MANAGER TO TAKE ALL ACTION NECESSARY TO IMPLEMENT THE TERMS OF THE INTERLOCAL AGREEMENT AND THE AGREEMENT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, Florida International University (“FIU”) provided the City of North Miami (the “City”) and the North Miami Community Redevelopment Agency (“NMCRA”) with a proposal to provide the FIU Construction Trades Program (the “Program”) for an amount not to exceed approximately \$225,000.00; and

WHEREAS, the City desires to enter into an Interlocal Agreement with the NMCRA for funding in the amount of \$100,000 for the Program, with the City to provide the balance of the funding for the Program; and

WHEREAS, the City desires to enter into an Agreement with the NMCRA and FIU pursuant to which FIU will provide the Program pursuant to the Proposal; and

WHEREAS, the Mayor and City Council desire to (a) authorize the negotiation, finalization and execution of an Interlocal Agreement with the NMCRA to provide funding in the amount of \$100,000 for the Program and the City to provide the balance of the funding for the Program and (b) authorize the negotiation, finalization and execution of an Agreement with the NMCRA and FIU pursuant to which FIU will provide the Program pursuant to the Proposal, which

agreements shall be in a form and substance as negotiated by the Interim City Manager and approved as to legal form and sufficiency by the City Attorney.

WHEREAS, the Mayor and City Council desires to approve the Interlocal Services Agreement relating to the provision of funding for the FIU Construction Trades Program, in substantially the form attached as Exhibit "A."

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of Interlocal Agreement with NMCRA. The Mayor and City Council hereby authorize the Interim City Manager and City Attorney to negotiate and finalize an Interlocal Agreement with the NMCRA for the NMCRA to provide funding in the amount of \$100,000 for the Program, with the City to provide the balance of the funding for the Program.

Section 2. Approval of Agreement with FIU. The Interim City Manager and the City Attorney are hereby authorized to negotiate and finalize an Agreement with the NMCRA and FIU pursuant to which FIU will provide the Program pursuant to the Proposal

Section 3. Implementation of Interlocal Service Agreement and FIU Agreement.
The Interim City Manager is hereby authorized to take all actions necessary to implement the terms and conditions of the Interlocal Services Agreement and the Agreement.

Section 4. Effective Date. This Resolution shall be effective immediately upon approval.
