

RESOLUTION NO. 2025-R-91

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS TO AIP US, LLC, IN AN AMOUNT NOT TO EXCEED FORTY-ONE THOUSAND THREE HUNDRED EIGHTY-FIVE DOLLARS (\$41,385.00), FOR THE PURCHASE OF CISCO FIREPOWER SOFTWARE UPGRADES THROUGHOUT THE CITY, PURSUANT TO SECTION 7-121(21) OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami ("City") Information Technology Department has identified security solutions required to manage cybersecurity services within the City; and

WHEREAS, the IT department recommends the purchase of physical firewall devices that will protect internal resources such as servers from inside and outside threats; and

WHEREAS, the recommended Cisco Firepower software upgrades will be purchased from AIP US, LLC in an amount not to exceed Forty-One Thousand Three Hundred Eighty-Five Dollars (\$41,385.00); and

WHEREAS, in accordance with Section 7-121(21) of the City Code, the purchase of telecommunications, internet, and cybersecurity services are exempt from the provisions of the Procurement Code; and

WHEREAS, City administration respectfully requests that the Mayor and City Council authorize the issuance of the purchase order, pursuant to Section 7-121(21), City Code of Ordinances.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of Interim City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue Purchase Orders in an amount not-to-exceed exceed Forty-One Thousand Three Hundred Eighty-Five Dollars (\$41,385.00), to AIP US, LLC for the purchase of Cisco Firepower software upgrades throughout the City, pursuant to Section 7-121(21), City Code of Ordinances.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
