



North Miami Crash Data Summary




13,204 crashes in 6 years


Using FDOT's comprehensive unit crash costs, the average annual crash cost is ~\$150M



Fatal and Incapacitating Injury Crashes




35 fatal and 104 incapacitating injury crashes in 6 years










VRU Crashes by Mode Type



Fatal or serious injury (77)









Fatal Crashes Only



VRU Fatal & Incapacitating Injury Crashes






