

**RESOLUTION NO. 2025-R-102**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE LEASE AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND TOSHIBA AMERICA BUSINESS SOLUTIONS, INC. D/B/A TOSHIBA BUSINESS SOLUTIONS TO PROVIDE FOR THE CONTINUATION OF PRINTING, COPYING, AND MAINTENANCE SERVICES AT THE EXISTING RATES AND FOR THE CONSOLIDATION OF DEPARTMENTAL SUB-LEASE AGREEMENTS INTO ONE (1) MASTER LEASE AGREEMENT FOR A TERM OF THIRTY-NINE (39) MONTHS, AT AN AMOUNT NOT TO EXCEED FIFTY-FOUR THOUSAND FIVE HUNDRED TWENTY-EIGHT DOLLARS (\$54,528.00) ANNUALLY; FURTHER AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS FOR PAYMENT OF SERVICES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on January 26, 2021, the City of North Miami ("City") adopted Resolution No. 2021-R-14, which authorized the issuance of purchase orders to Toshiba America Business Solutions, Inc. d/b/a Toshiba Business Solutions ("Toshiba") for the provisions of copier services through the cooperative purchasing provision provided for in section 7-169 of the City Code; and

**WHEREAS**, under this contract, Toshiba entered into sub-leases with the City departments for copier services; and

**WHEREAS**, the City is desirous of entering into an amended contract with Toshiba to provide for the continuation of services at the existing rates and to consolidate the sub-leases with the City departments into one (1) Master Lease Agreement for a term of Thirty-Nine (39) months; and

**WHEREAS**, Copier services under the proposed Master Lease Agreement will be provided for an annual cost not to exceed Fifty-Four Thousand Five Hundred Twenty-Eight Dollars (\$54,528.00); and

**WHEREAS**, the Mayor and City Council find that entering into a Master Lease Agreement with Toshiba to continue copier services is in the best interest of the City.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of Interim City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and City Attorney to negotiate and execute an Amendment to the Lease Agreement between the City of North Miami and Toshiba America Business Solutions, Inc. d/b/a Toshiba Business Solutions to provide for the continuation of printing, copying, and maintenance services at the existing rates and for the consolidation of departmental sub-lease agreements into one (1) Master Lease Agreement for a term of Thirty-Nine (39) months.


**Section 2. Issuance of Purchase Orders.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue Purchase Orders to Toshiba Business Solutions, Inc. in an amount not to exceed Fifty-Four Thousand Five Hundred Twenty-Eight Dollars (\$54,528.00) annually.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
