

RESOLUTION NO. 2025-R-101

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS FOR THE PURCHASE OF THE FOLLOWING VEHICLES: FOUR (4) PICK-UP TRUCKS, THREE (3) CARGO VANS, THREE (3) SPORT UTILITY VEHICLES, TWO (2) DUMP TRUCKS, ONE (1) CHIPPER, ONE (1) COMPACT LOADER, ONE (1) MINI-EXCAVATOR, AND ONE (1) TRAILER, AT AN APPROXIMATE-AGGREGATE COST NOT TO EXCEED NINE HUNDRED THOUSAND DOLLARS (\$900,000) FROM VARIOUS COMPETITIVELY SELECTED VENDORS; UTILIZING THE COOPERATIVE PURCHASING PROVISION PURSUANT TO SEC. 7-169 OF THE CITY CODE, ON CONTRACTS AWARDED THROUGH THE FLORIDA SHERIFFS ASSOCIATION, UNDER CONTRACT NUMBERS FSA24-VEH320.0, FSA23-VEL21.1, AND FSA23-EQUI21.0, THROUGH SOURCEWELL UNDER CONTRACT NO. 020223-CEC AND 031721-MBI, AND UNDER THE STATE OF FLORIDA DEPARTMENT OF MANAGEMENT SERVICES CONTRACT NUMBER 25100000-23-STC; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Florida Sheriffs Association ("FSA"), Sourcewell, and the State of Florida Department of Management Services ("DMS") offers statewide purchasing contracts for a variety of vehicles, equipment, and services that are available to eligible agencies such as the City of North Miami. Contracts awarded through these programs are competitively bid and offer favorable pricing and terms for eligible agencies to take advantage of; and

WHEREAS, the contracts are designed to provide participating agencies and local municipal governments with a mechanism for increasing their purchasing power by offering the most economically priced cars, trucks, vans, and equipment tailored to the agency's specific requirements; and

WHEREAS, utilization of the FSA, Sourcewell, and DMS contracts guarantees participating agencies and local municipal governments the availability of competitive pricing under the Award by selected vendors ("Vendors"), as long as vehicles and equipment are available to order through the manufacturer; and

WHEREAS, City desires to purchase certain equipment utilizing the following contracts awarded through FSA, Sourcewell, and the DMS: *FSA23-VEH21.1 – Heavy Trucks & Buses, FSA24-VEL32.0 - Pursuit, Administrative, and Other Vehicles, FSA23-EQUI21.0 – Heavy Equipment, Sourcewell – 020223-CEC-Loaders and 031721-MBI – Brush Chippers, and DMS Contract No. 25100000-23-STC*; and

WHEREAS, the City administration has identified the need for the following vehicles: Four (4) Pick-Up Trucks, Three (3) Cargo Vans, Three (3) Sport Utility Vehicles, Two (2) Dump Trucks, One (1) Chipper, One (1) Compact Loader, One (1) Mini-Excavator, and One (1) Trailer (collectively referred to herein as “Vehicles and Equipment”); and

WHEREAS, the Vehicles will be purchased at an approximate aggregate cost not to exceed Nine Hundred Thousand Dollars (\$900,000.00), from competitively selected Vendors; and

WHEREAS, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

WHEREAS, the City Manager has determined that it is in the City’s best interest to expeditiously purchase the equipment for immediate public-service use, while utilizing the most cost-effective means currently available to the City.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue Purchase Orders for the purchase of the following vehicles: Four (4) Pick-Up Trucks, Three (3) Cargo Vans, Three (3) Sport Utility Vehicles, Two (2) Dump Trucks, One (1) Chipper, One (1) Compact Loader, One (1) Mini-Excavator, and One (1) Trailer, at an approximate-aggregate cost not-to-exceed Nine Hundred Thousand Dollars (\$900,000.00) from various competitively selected vendors, utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code, on contracts awarded through the Florida Sheriffs Association, Sourcewell, and the State of Florida Department of Management Services, under Contract numbers: *FSA23-VEH21.1 – Heavy Trucks & Buses, FSA24-VEL32.0 - Pursuit, Administrative, and Other Vehicles, FSA23-EQUI21.0 – Heavy*

Equipment, Sourcewell – 020223-CEC-Loaders and 031721-MBI – Brush Chippers, and DMSNo. 25100000-23-STC.

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
