

RESOLUTION NO. 2025-R-112

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING A PROPOSED CHANGE ORDER TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND SPORT SURFACES, LLC, FOR ADDITIONAL SERVICES RELATED TO THE RESURFACING OF THE PENNY SUGARMAN TENNIS CENTER COURTS, IN AN AMOUNT NOT TO EXCEED FIFTY-ONE THOUSAND DOLLARS (\$51,000.00), PURSUANT TO INVITATION FOR BIDS NO. 07-24-25; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on October 23, 2024, the City of North Miami (“City”) advertised *Invitation for Bid No. 07-24-25 – Re-Surfacing of the Penny Sugarman Tennis Center Courts Project* (“IFB”), soliciting bids from qualified, licensed, and experienced contractors to provide all the necessary labor, materials, equipment and expertise needed for the successful resurfacing of the Penny Sugarman Tennis Center located at 1795 Sans Souci Boulevard, in accordance with the specifications and conditions contained in the IFB (collectively referred hereto as “Services”); and

WHEREAS, in response to the IFB, Sport Surfaces, LLC (“Contractor”) submitted its bid and was competitively selected by City administration as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, on February 25, 2025, the Mayor and City Council of the City of North Miami, Florida, adopted Resolution No. 2025-R-50 authorizing the City Manager to negotiate and execute an agreement between the City of North Miami and Sport Surfaces, LLC, for Services related to the Penny Sugarman Tennis Court Resurfacing Project to be provided in an amount not exceeding Two Hundred Seventy Thousand Six Hundred Dollars (\$270,600.00); and

WHEREAS, Contractor has provided a proposal for the application of a full fiberglass membrane across all twelve (12) tennis courts; and

WHEREAS, City administration recommends the purchase of additional services, in an amount not to exceed Fifty-One Thousand Dollars (\$51,000.00); and

WHEREAS, City administration respectfully requests that the Mayor and City Council authorize the proposed change order to the existing agreement with the Contractor for the provision of additional tennis court resurfacing services.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Authority of Interim City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue the proposed change order to the existing agreement between the City of North Miami and Sport Surfaces, LLC, for additional resurfacing services, in an amount not to exceed Fifty-One Thousand Dollars (\$51,000.00).

Section 2. **Effective Date.** This Resolution shall be effective upon adoption.
