

RESOLUTION NO. 2025-R-110

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE INTERIM CITY MANAGER TO
ISSUE PURCHASE ORDERS TO ALLIED UNIVERSAL
CORPORATION, FOR A ONE (1) YEAR TERM, IN THE
AGGREGATE AMOUNT NOT TO EXCEED ONE
HUNDRED TWENTY THOUSAND DOLLARS (\$120,000.00),
FOR THE PURCHASE AND DELIVERY OF LIQUID
SODIUM HYPOCHLORITE FOR THE WINSON WATER
TREATMENT PLANT, UTILIZING PEACE RIVER
MANASOTA REGIONAL WATER SUPPLY AUTHORITY'S
CONTRACT; PROVIDING FOR AN EFFECTIVE DATE
AND ALL OTHER PURPOSES.**

WHEREAS, Sodium Hypochlorite is an essential ingredient in the ongoing operation of the City of North Miami ("City") Winson Water Treatment Plant and for the provision of potable water to all City water consumers; and

WHEREAS, on February 7, 2025, Peace River Manasota Regional Water Supply Authority ("Peace River") advertised *Invitation for Bids ("IFB") – Water Treatment Chemicals* ("Solicitation"), requesting competitive sealed bids from qualified vendors for the purchase and delivery of chemicals for the Peace River Authority; and

WHEREAS, as a result of the Solicitation, Allied Universal Corporation ("Vendor") was evaluated and selected to be the lowest responsive and responsible bidder for the provision of Liquid Sodium Hypochlorite; and

WHEREAS, on May 1, 2025, Peace River entered into an agreement with Allied in accordance with the IFB for an initial one (1) year term and two (2) one-year renewal options; and

WHEREAS, in accordance with Section 7-167 of the City Code, the City administration may purchase supplies or services from current contracts of other governmental agencies, with City Council approval on any such purchase which exceeds Thirty Thousand Dollars (\$30,000.00); and

WHEREAS, the City administration desires to utilize the existing Agreement between Peace River and Vendor to obtain competitive pricing; and

WHEREAS, City administration respectfully requests approval to use Vendor's contract with Peace River for issuance of Purchase Orders, for a one (1) year term, in an amount not to exceed One Hundred Twenty Thousand Dollars (\$120,000.00) to provide the Winson Water Treatment Plant with Sodium Hypochlorite; and

WHEREAS, the Mayor and City Council find that the purchase of Liquid Sodium Hypochlorite, in accordance with the Solicitation, is in the best interest of the City.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue purchase orders, for a one (1) year term, with two (2) options to renew at the discretion of the Interim City Manager, to Allied Universal Corporation, in an aggregate amount not to exceed One Hundred Twenty Thousand Dollars and 00/100 (\$120,000.00) for purchase and delivery of Liquid Sodium Hypochlorite for the Winson Water Treatment Plant, utilizing Peace River Manasota Regional Water Supply Authority, *Invitation for Bids ("IFB") – Water Treatment Chemicals*, pursuant to Section 7-167 of the Code of Ordinances.

Section 2. Effective Date. This Resolution shall be effective upon adoption.


