

**RESOLUTION NO. 2025-R-108**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE EXECUTION OF A LAW ENFORCEMENT AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND LEXISNEXIS COPLOGIC SOLUTIONS INC., TO PROVIDE CERTAIN SERVICES INCLUDING ONLINE DISTRIBUTION OF POLICE REPORTS AND A DESK OFFICER REPORTING SYSTEM (“DORS”); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) Police Department (“NMPD”) desires to engage LexisNexis Coplogic Solutions Inc. (“LexisNexis”) to serve as its exclusive online distributor of crash reports and to implement a Desk Officer Reporting System (“DORS”) platform to enhance public access and departmental efficiency; and

**WHEREAS**, LexisNexis is a company that provides software and technology solutions to law enforcement agencies, including digital platforms for public access to crash reports and systems for citizen self-reporting; and

**WHEREAS**, LexisNexis has proposed a revenue-sharing arrangement in which a portion of the fees collected from report requestors will be remitted to the City and applied toward offsetting the cost of DORS services; and

**WHEREAS**, the DORS platform will provide residents, businesses, and visitors with a convenient option to file non-emergency police reports remotely, reducing administrative burden on officers and enhancing customer service delivery; and


**WHEREAS**, the Mayor and City Council find it in the best interest of the City and its residents to enter into an agreement with LexisNexis to enhance public access to police reports, improve operational efficiency within NMPD, and implement technology-driven solutions that support transparency, convenience, and community engagement.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


**Section 1.**      **Authority of Interim City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to execute a Law Enforcement Agreement between the City of North Miami and LexisNexis Coplogic Solutions Inc.

**Section 2.**      **Effective Date.** This Resolution shall become effective immediately upon adoption.
