

RESOLUTION NO. 2025-R-123

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE AGREEMENT WITH AECOM TECHNICAL SERVICES, INC., IN AN AMOUNT NOT TO EXCEED THREE HUNDRED SIXTY-FOUR THOUSAND EIGHT HUNDRED SEVENTEEN DOLLARS (\$364,817.00), FOR THE PROVISION OF ADDITIONAL ENGINEERING SERVICES RELATED TO THE UPDATE OF THE CITY'S WASTEWATER COLLECTION AND CONVEYANCE SYSTEM HYDRAULIC MODEL AND CALIBRATION SERVICES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on September 27, 2022, the Mayor and City Council of the City of North Miami ("City") adopted Resolution No. 2022-R-153 authorizing the City Manager to enter into an Agreement with AECOM Technical Services, Inc. ("Consultant"), to provide the City with and Infrastructure Study of the City's potable water distribution and sanitary sewer collection systems in support of the Comprehensive Plan Update, in accordance with the technical specifications, terms, and conditions contained in the *Request for Qualifications #08-17-18, Continuing Architectural & Engineering Services* ("RFQ"); and

WHEREAS, the City desires to amend the Agreement to include additional engineering services needed to update the City's wastewater collection and conveyance system hydraulic model and calibration services ("Services"); and

WHEREAS, the additional services will include: project management, data collection and review, estimation of sanitary sewer flows, hydraulic model update, hydraulic model calibration, development of the 20-Year Capital Improvement Plan, and a technical memorandum; and

WHEREAS, the required additional Services will cost the City an amount not to exceed Three Hundred Sixty-Four Thousand Eight Hundred Seventeen Dollars (\$364,817.00), with an estimated project completion date of twelve (12) months from the notice to proceed; and

WHEREAS, the City Administration respectfully requests that the Mayor and City Council approve the proposed amendment to Agreement, in order to finalize the update to the City's wastewater collection and conveyance system hydraulic model.


WHEREAS, the Mayor and City Council have determined that it is in the City's best interests to authorize the Interim City Manager and City Attorney to negotiate and execute an amendment to the agreement for the provision of the required additional engineering services.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, THAT:


Section 1. **Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to execute an amendment to Agreement, between the City of North Miami and AECOM Technical Services, Inc., to include additional engineering services needed for the update of the City's wastewater collection and conveyance system hydraulic model and calibration services, at a cost not to exceed Three Hundred Sixty-Four Thousand Eight Hundred Seventeen Dollars (\$364,817.00).

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
