

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE EXECUTION OF A MODIFICATION TO MASTER RESEARCH AGREEMENT (AGREEMENT #C-24-026) BETWEEN THE CITY OF NORTH MIAMI AND FLORIDA ATLANTIC UNIVERSITY ("FAU"), FOR THE DEVELOPMENT OF WATERSHED MASTER PLAN, TO PROVIDE FOR AN EXTENSION OF TIME IN WHICH TO COMPLETE THE WATERSHED MASTER PLAN; PROVIDING FOR AN EFFECTIVE DATE, AND ALL OTHER PURPOSES.

WHEREAS, on November 28, 2023, the Mayor and City Council adopted Resolution No. 2023-R-222 authorizing the City of North Miami ("City") to enter into a Master Research Agreement with Florida Atlantic University ("FAU") for the development of a Watershed Master Plan; and

WHEREAS, the City and FDEM are desirous of entering into a modification to the subgrant agreement to provide for an extension of time, which will provide for the project to be completed by December 31, 2025; and

WHEREAS, the Mayor and City Council wish to authorize the execution of a Modification to the Master Research Agreement between the City and FAU.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Authorization. The Mayor and City Council hereby authorize the execution of a Modification to the Master Research Agreement between the City of North Miami and Florida Atlantic University.

Section 2. Authority to Interim City Manager and City Attorney. The Interim City Manager and City Attorney are hereby authorized to negotiate and execute any documents necessary in support of the modification to the agreement between the City of North Miami, Florida, and Florida Atlantic University.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
