**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE EXECUTION OF A MEMORANDUM
OF UNDERSTANDING, BETWEEN THE CITY OF NORTH
MIAMI AND PROSPERITY SOCIAL COMMUNITY
DEVELOPMENT GROUP, INC., IN SUPPORT OF THE
“SHINE BRIGHT” AFTER-SCHOOL AND SUMMER CAMP
PROGRAM AT THE NORTH MIAMI PUBLIC LIBRARY;
PROVIDING FOR AN EFFECTIVE DATE AND ALL
OTHER PURPOSES.**

WHEREAS, Prosperity Social Community Development Group, Inc. (“PSCDG”) is a Florida-based 501(c)(3) nonprofit organization that provides literacy-focused educational programs to support families and students in improving academic performance, social skills, and self-esteem; and

WHEREAS, the City of North Miami (“City”) desires to continue its twelve-year collaboration with PSCDG to offer the Shine Bright After-School and Summer Camp Program at the North Miami Public Library; and

WHEREAS, the program will serve City residents in grades K-5 with activities such as story time, summer reading, remote learning support, and access to the Library’s collections and technology resources; and

WHEREAS, the program will be fully administered, staffed, and funded by PSCDG, with no financial impact to the City; and

WHEREAS, the Mayor and City Council find that entering into a Memorandum of Understanding with Prosperity Social Community Development Group, Inc. to establish a structured learning environment at the North Miami Public Library will serve the best interests of the City and its residents by supporting both students and their families.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

Section 1. **Authority of Interim City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to execute a Memorandum of Understanding, in substantially the attached form, between the City of North Miami and Prosperity Social Community Development Group, Inc., in support of the "Shine Bright" After-School and Summer Camp Program at the North Miami Public Library.

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
