

RESOLUTION NO. 2025-R-129

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING RESOLUTION NUMBER 2025-R-113 TO REFLECT THE CITY OF NORTH MIAMI'S CO-DESIGNATION OF THAT PORTION OF NORTHEAST 131ST STREET BETWEEN NORTHEAST 2ND AVENUE AND NORTH MIAMI AVENUE, AND THAT PORTION OF NORTHWEST 131ST STREET BETWEEN NORTHWEST 2ND AVENUE AND NORTHWEST 13TH AVENUE, AS "COUNCILMAN JACQUES DESPINOSSE STREET", AS APPROVED BY THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on May 27, 2025, the Mayor and City Council adopted Resolution Number R-2025-R-113, approving the co-designation of a portion of 131st Street from Northeast 2nd Avenue to Northeast 7th Avenue to be known as "COUNCILMAN JACQUES DESPINOSSE STREET" and also naming Breezeswept Park in honor of former Councilman Jacques Despinosse; and

WHEREAS, on May 20, 2025, the Miami-Dade County Board of County Commissioners adopted Resolution R-471-25, (1) co-designating that portion of Northwest 131st Street between North Miami Avenue and Northwest 2nd Avenue as "Councilman Jacques Despinosse Street;" and (2) approving the City's co-designations of that portion of Northeast 131st Street between Northeast 2nd Avenue and North Miami Avenue, and that portion of Northwest 131st Street between Northwest 2nd Avenue and Northwest 13th Avenue, as "Councilman Jacques Despinosse Street,"; and

WHEREAS, in deliberation of the proposed resolution, the Mayor and City Council opted to amend the co-designation to change the avenue of the street designation from N.W. 14th Avenue to N.W. 7th avenue; and

WHEREAS, it is recommended that the adopted resolution be amended to reflect the street designation as approved the Miami-Dade County Commissioners to maintain consistency; and


WHEREAS, the Mayor and City Council are desirous of amending Resolution Number R-2025-R-1113 to reflect the City's co-designation of that portion of Northeast 131st Street between Northeast 2nd Avenue and North Miami Avenue, and that portion of Northwest 131st Street between Northwest 2nd Avenue and Northwest 13th Avenue, as "Councilman Jacques Despinosse Street,".

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA:**

Section 1. **Amendment.** That the Mayor and City Council of the City of North Miami, Florida, hereby amend Resolution No. 2025-R-1113 to reflect the City's co-designation of that portion of Northeast 131st Street between Northeast 2nd Avenue and North Miami Avenue, and that portion of Northwest 131st Street between Northwest 2nd Avenue and Northwest 13th Avenue, as "Councilman Jacques Despinosse Street,".

Section 2. **Effective Date.** This Resolution shall be effective immediately upon adoption.
