

RESOLUTION NO. 2025-R-128

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE INTERIM CITY MANAGER TO
EXECUTE AN INTERAGENCY AGREEMENT WITH
THE MIAMI-DADE SHERIFF'S OFFICE TO PERMIT
ACCESS TO THE FLORIDA CRIME INFORMATION
CENTER ("FCIC"), NATIONAL CRIME INFORMATION
CENTER ("NCIC"), AND RELATED SYSTEMS FOR THE
ADMINISTRATION OF CRIMINAL JUSTICE;
PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL
OTHER PURPOSES.**

WHEREAS, the City of North Miami ("City"), through its North Miami Police Department ("NMPD"), seeks to access critical criminal justice information systems to effectively carry out its public safety mission; and

WHEREAS, the Miami-Dade Sheriff's Office ("MDSO") is an established conduit for access to the Florida Crime Information Center ("FCIC"), the National Crime Information Center ("NCIC"), the Law Enforcement Interface System ("LEIS"), the Electronic Arrest Form ("E-A-FORM"), and the Miami-Dade Criminal Justice Information System ("CJIS"); and

WHEREAS, the NMPD and MDSO are recognized criminal justice agencies under federal and state law and are authorized to enter into an interagency agreement to facilitate such access in compliance with all applicable laws, regulations, and security policies; and

WHEREAS, the proposed interagency agreement establishes mutual responsibilities and terms of access, indemnification, and termination provisions necessary to ensure lawful and secure data use; and

WHEREAS, the City of North Miami recognizes that timely and secure access to accurate criminal justice information is essential for ensuring public safety, enhancing investigative efficiency, supporting officer safety, and enabling compliance with state and federal mandates; and

WHEREAS, authorizing the execution of the Interagency Agreement with MDSO will enable the NMPD to access critical law enforcement databases and systems, including FCIC, NCIC, LEIS, E-A-FORM, and the Miami-Dade CJIS, thereby improving the City's ability to

administer criminal justice services effectively and in accordance with applicable security protocols and regulations; and


WHEREAS, the Mayor and City Council find it in the best interest of the City to authorize the execution of the agreement with MDSO, as it will facilitate regional cooperation, improve operational capacity, and enhance law enforcement capabilities through lawful information sharing, all of which will benefit City residents and promote public welfare.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. **Authority of the Interim City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to execute this Interagency Agreement, in substantially the form attached hereto as Exhibit "A," with the Miami-Dade Sheriff's Office to permit access to FCIC/NCIC, LEIS, E-A-FORM, and the Miami-Dade CJIS System for criminal justice purposes

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
