

RESOLUTION NO. 2025-R-142

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE A GRANT AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (“FDEP”), TO SECURE A GRANT IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000.00) FOR THE N.E. 121 STREET DRAINAGE IMPROVEMENTS PROJECT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of securing a grant from the Florida Department of Environmental Protection (“FDEP”); and

WHEREAS, the City of North Miami (“City”) submitted a Fiscal Year 2024-2025 local funding initiative request and appropriations project request in support of the N.E. 121 Street Drainage Improvements Project; and

WHEREAS, the City has been awarded a grant in the amount of One Hundred Fifty Thousand Dollars (\$150,000.00) with no required match for a total project cost in the amount of One Hundred Fifty Thousand Dollars (\$150,000.00); and

WHEREAS, funds will be used to address the localized flooding challenges along N.E. 121st Street between N.E. 10th Avenue and N.E. 11th Court by constructing meaningful drainage infrastructure; and

WHEREAS, the Mayor and City Council wish to authorize the execution of an agreement for grant funds between the City and the Florida Department of Environmental Protection.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Ratification and Approval. The Mayor and City Council hereby ratifies and approves the acceptance of the grant from the Florida Department of Environmental Protection, in the amount of One Hundred Fifty Thousand Dollars (\$150,000.00), in support of the N.E. 121 Street Drainage Improvements Project.

Section 2. Authority to Interim City Manager. The Interim City Manager is hereby authorized to execute an agreement between the City of North Miami, Florida, and the Florida Department of Environmental Protection.


Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.


