

RESOLUTION NO. 2025-R-141

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE A GRANT AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (“FDEP”), TO SECURE A RESILIENT FLORIDA PROGRAM GRANT IN THE AMOUNT OF TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00) IN SUPPORT OF THE CITY OF NORTH MIAMI’S SHORELINE MASTER PLAN UPDATE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of securing a grant from the Florida Department of Environmental Protection (“FDEP”); and

WHEREAS, the City of North Miami (“City”) was awarded a grant under the Fiscal Year 2024-2025 General Appropriations Act through the FDEP Resilient Florida grant program; and

WHEREAS, the City has been awarded a grant in the amount of Twenty-Five Thousand Dollars (\$25,000.00) with no required match for a total project cost in the amount of Twenty-Five Thousand Dollars (\$25,000.00); and

WHEREAS, funds will be used toward the City of North Miami Shoreline Master Plan Update which includes ecological assessments, invasive species mitigation strategies, restoration planning, and public engagement to advance shoreline resilience; and

WHEREAS, the Mayor and City Council wish to authorize the execution of an agreement for grant funds between the City and the Florida Department of Environmental Protection.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Ratification and Approval. The Mayor and City Council hereby ratifies and approves the acceptance of the grant from the Florida Department of Environmental Protection, in the amount of Twenty-Five Thousand Dollars (\$25,000.00), in support of the City of North Miami’s Shoreline Master Plan Update.

Section 2. Authority to Interim City Manager. The Interim City Manager is hereby authorized to execute an agreement between the City of North Miami, Florida and the Florida Department of Environmental Protection.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
