

RESOLUTION NO. 2025-R-133

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPOINTING HECTOR MEDINA TO THE CENTENNIAL COMMITTEE, TERM ENDING ON NOVEMBER 03, 2026, IN ACCORDANCE WITH CITY OF NORTH MIAMI RESOLUTION NO. 2023-R-118; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on July 11, 2023, the Mayor and City Council established an advisory committee to be known as the Centennial Committee to develop a vision for the City's centennial celebration for February 2026; and

WHEREAS, in accordance with Resolution 2023-R-118, the Centennial Committee shall be comprised of five (5) members, with the Mayor and each Councilperson appointing one (1) individual to the committee; and

WHEREAS, the jurisdiction of the Committee shall be solely advisory and shall include developing a vision for the City's centennial celebration, which vision may incorporate and recommend potential activities, events, decorations, promotions, themes, and other preparations for the City's centennial and providing the City with input, assistance, and recommendations regarding such other matters relating to the City's centennial celebration that the City Council may assign to the Committee; and

WHEREAS, Councilman Kevin A. Burns desires to appoint Hector Medina to the Centennial Committee.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Recitals. The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

Section 2. Appointment. The Mayor and City Council of the City of North Miami, Florida, hereby appoints Hector Medina to the Centennial Committee.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
